INVITATION TO BID
Construction of OCD-NDRRMC Warehouse

1. The *Office of Civil Defense*, through the DND Bids and Awards Committee (BAC) invites bids for the Construction of OCD-NDRRMC Warehouse for the OCD-NDRRMC ("the Project"), detailed as follows:

Location	OCD-Annex Building Camp General E. Aguinaldo, Quezon City
Funding Source	DND-Quick Response Fund FY 2008 and 2010
Approved Budget for the Contract	Sixteen Million Seven Hundred Eighty Four Thousand Five Hundred Twenty Pesos and 52/100 (Php 16,784,520.52)
PCAB License Required	Medium "A"
Contract Completion Period	One Hundred Twenty (120) Calendar Days

2. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (IRR) of the Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act". Bids received in excess of the Approved Budget for the Contract (ABC) shall be automatically rejected at the bid opening.

3. Moreover, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. Foreign Bidder may be eligible to participate in the procurement of infrastructure projects only when authorized under any treaty or international or executive agreement as provided in Section 23.5.2.2 of the Revised IRR of R.A. No. 9184.

4. Also, Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, which must have a value of at least fifty percent (50%) of the ABC. The complete description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

5. A complete set of Bidding Documents may be purchased by interested Bidders from the DND-BAC Secretariat, DND Ground Floor, Camp General E. Aguinaldo, Quezon City upon payment of non-refundable fee in the amount of **Twenty Five Thousand Pesos (PhP25,000.00)**.

6. The DND-BAC will hold a Pre-Bid Conference on December 16, 2011 at 10:00 am at the DND Conference Room, DND Ground floor, Camp General Emilio Aguinaldo, Quezon City which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the above address on or before December 29, 2011, 10:00 a.m. All bids, which must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Interested bidders may obtain further information from the Office of Civil Defense and inspect the Bidding Documents at the address given below from 8:00 a.m. – 5:00 p.m.



10. The Office of Civil Defense reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
